## Service Charge

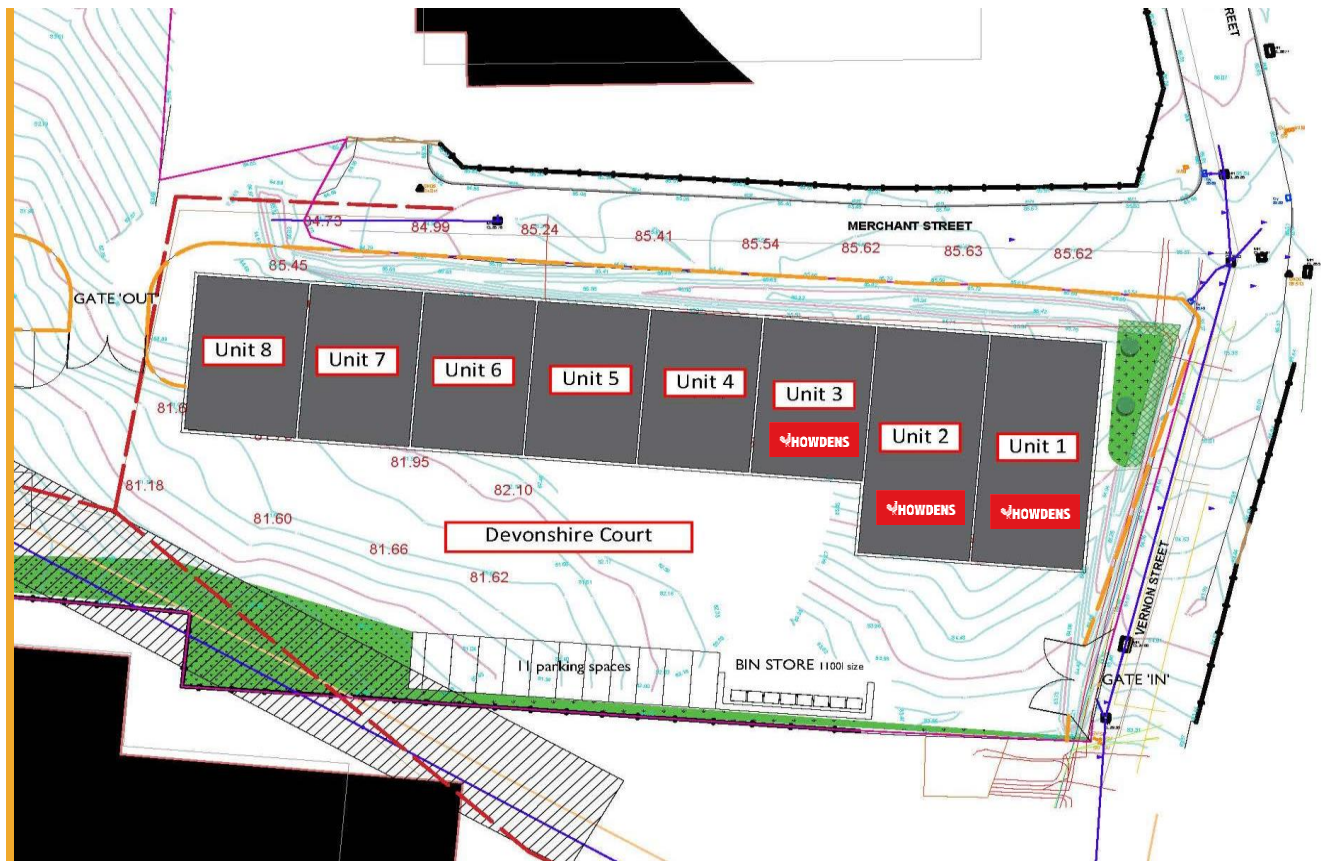

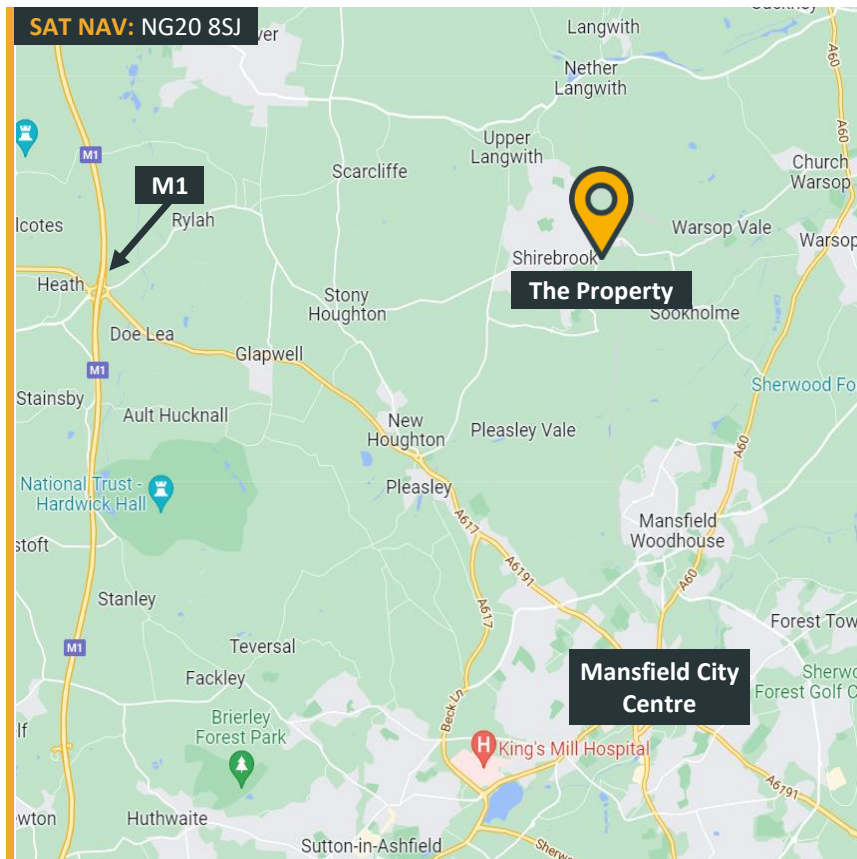
## Business Rates
