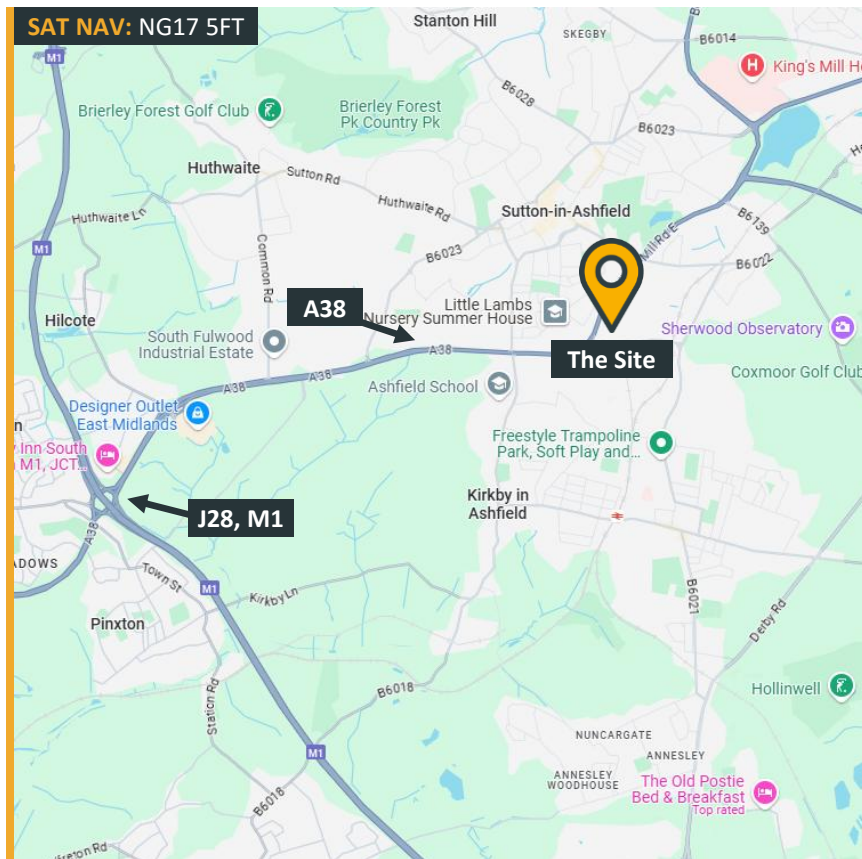
EPC
